Purpose of This Privacy Policy

This Privacy Policy explains how we collect, process, use, store, and protect the personal data of individuals (data subjects). Its purpose is to help you understand what information we collect, why we collect it, and how it is handled.

What Are Personal Data?

Personal data is any information that relates to an identified or identifiable individual.

When This Privacy Policy Applies

This Privacy Policy applies to all personal data processed by SIA “Divi Berzini”, regardless of how the data is submitted — in paper form, electronically, through our website, online store, or in person.

Basic Information

Purpose of processing: To conclude purchase/service agreements, deliver goods, administer payments, and fulfil warranty obligations.

Data controller: SIA “Divi Berzini”, registration No. 40203088061

Legal basis: Legitimate interests of SIA “Divi Berzini”.

Transfer to third countries: Not performed.

Data recipients: The data controller, authorized processors, law enforcement authorities, cooperation partners, service providers, database administrators, cloud service providers, accounting services, and legal service providers.

How and Why We Process Personal Data

We process personal data to fulfil the goals described in this Privacy Policy — including performing commercial activities, meeting legal requirements, securely handling and storing data, and complying with consumer protection regulations.

Data retention: Personal data are stored only for as long as necessary to meet legal or contractual requirements. When data are no longer needed, they are securely deleted.

Data security: Personal data are processed using secure software, antivirus systems, firewalls, and other protective technologies. Access is restricted and protected by access controls.

Transfer of Personal Data

Personal data are not transferred to countries outside the EU/EEA.

Data may be shared with cooperation partners, service providers, and authorized individuals (lawyers, accountants, IT specialists) only as much as needed to fulfil legitimate interests, using secure technologies.

Commercial Communication

Protection of Personal Data

Personal data are protected according to applicable EU and Latvian data protection laws and regulations.

Access to Your Data
